- If the participant requires a carer they will be granted access at no charge when accompanying the individual. Please inform the YMCA prior to the initial visit to the Centre.
- The YMCA has an expectation that the participant will commit to making the most of their access by attending as often as possible. Attendance rates are considered when assessing applications to extend the period of access.
- The YMCA understands that circumstances may at times affect your ability to attend the Centre. If this occurs, please contact the YMCA you are attending to discuss. Unexplained non-attendance may result in the cessation of your access.
- YMCA Open Doors applicants will be required to pay a portion of the fees for programs accessed.
- The purpose of the YMCA Open Doors program is to assist those in disadvantaged circumstances to primarily attend YMCA programs and activities. The objective is to support the development of young people. Requests will be considered individually based on the information provided by the applicant and the referral agency.
- YMCA Open Doors will contribute no more than \$300.00 per calendar year per family. Please take this into consideration when completing your application.
- Please notify the YMCA immediately of any changes to your contact details.
- The participants experience in this program should be positive and enjoyable. If this is not the case, or you have any other feedback, please speak to the Program Coordinator.
- The YMCA Open Doors program requires that all applicants attend an informal meeting to discuss the application. If individuals are not willing to attend a meeting at a time that is convenient for both parties the application will be declined.
